WHEREAS, the President and Village Board have decided to eliminate parking fees for eligible handicapped motorists parking at the Metra parking facility.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, ILLINOIS AS FOLLOWS:

**SECTION I.** That Chapter 25, Comprehensive Fees and Penalties, Sec. 25-23, Traffic and Motor Vehicles – Chapter 22, of the Village of Vernon Hills Code of Ordinances be and is hereby amended to read:

Sec. 25-23. Traffic and Motor Vehicles--Chapter 22.

Handicapped space parking fine (any motor or self-propelled vehicle)	\$100.00 min.--\$500.00 max.

Daily Fee	\$1.75
Long-Term (per day, maximum of ten paid days)	\$1.75
Bimonthly Fee	\$55.00
<b>Designated handicapped parking for eligible handicapped motorists</b>	<b>No charge</b>

**SECTION II. Severability.** In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

**SECTION III. Repeal and Savings Clause.** All resolutions, policies or ordinances or parts thereof in conflict herewith are hereby repealed to the extent of such conflict; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.


**SECTION IV. Effective Date.** This ordinance shall be in full force and in effect from and after its passage, approval, and publication in pamphlet form as provided by law.




