ORDINANCE 2009-021

AN ORDINANCE CONSENTING TO THE CITY OF HIGHWOOD AS ADDITIONAL MEMBER OF THE SOLID WASTE AGENCY OF LAKE COUNTY, ILLINOIS (SWALCO) WITH NO LATE FEE

WHEREAS, Section 5.3 of the Intergovernmental Agreement establishing SWALCO contains provisions outlining how a Lake County municipal corporation may become an additional member of SWALCO; and

WHEREAS, the City of Highwood, Illinois have requested additional membership in SWALCO pursuant to Section 5.3 of the Intergovernmental Agreement but wish to avoid the payment of a late fee as described by that Section; and

WHEREAS, the Board of Directors of SWALCO has determined that the purpose of the inclusion of the late fee in Section 5.3 was to encourage the participation of municipalities to enter into said Intergovernmental Agreement from the beginning and prior to the expenditure or commitment of substantial public indebtedness; and

WHEREAS, SWALCO has not yet committed to the expenditure of substantial public indebtedness; and

WHEREAS, the inclusion of the City of Highwood would not substantially affect the planning and implementation process of SWALCO at this point in time; and

WHEREAS, Section 5.3 of the Intergovernmental Agreement provides for the abatement or waiver of said late fee.

NOW THEREFORE, BE IT ORDAINED, BY THE PRESIDENT AND VILLAGE BOARD OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE, STATE OF ILLINOIS, AS FOLLOWS:

Section 1. The Village of Vernon Hills does hereby grant its consent for the City of Highwood, Illinois to become Additional Member upon the payment of a late fee in the sum of No Dollars (\$0.00).

Section 2. That the City of Highwood shall be allowed to make their capital contribution to SWALCO upon a payment plan to be agreed upon separately by the City of Highwood requiring a payment of \$500 for ten years. The City of Highwood shall be obligated to sign a Note specifying said obligation.

Section 3. That this Ordinance shall be forwarded to the Secretary of SWALCO at 1131 N. Estes Street, Gurnee, IL 60031 upon its certification.






