**ORDINANCE NO. 2013-055**

**AN ORDINANCE REPEALING  
ORDINANCE 2013-044 AND CHAPTER  
3, LIQUOR CODE, SECTION 3-12(14),  
LICENSE CLASSIFICATION FOR  
CONVENIENCE STORES**

**WHEREAS**, on August 27, 2013, the Village of Vernon Hills passed Ordinance 2013-044, adding a new Section to the Village's Code of Ordinances, Chapter 3, "Liquor Code" Section 3-12(14), creating a new liquor license classification, "N" allowing the sale of alcoholic liquor in a convenience store; and

**WHEREAS**, the Board of Trustees has determined that further review of Ordinance 2013-044, Chapter 3, Section 3-12(14) is required and that certain changes to liquor license classification "N" may be warranted; and

**WHEREAS**, the Board of Trustees believes that repealing Ordinance 2013-044 and Chapter 3, Section 3-12(14) is appropriate.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION I.** Ordinance 2013-044 and Chapter 3 "Liquor Code", Section 3-12(14) is hereby repealed.

**SECTION II. SEVERABILITY.** In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications that are severable, the valid applications shall remain in effect.

**SECTION III. REPEAL AND SAVINGS CLAUSE.** All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

**SECTION VI. EFFECTIVE DATE.** This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

**SECTION V. PUBLICATION.** This ordinance shall be published in pamphlet for in the manner provided by law.




