**ORDINANCE NO. 2014-013**

**AN ORDINANCE AUTHORIZING  
THE SALE OF CERTAIN PERSONAL  
PROPERTY OWNED BY THE  
VILLAGE**

WHEREAS, the Village is a home rule municipal corporation organized and existing under the Constitution of the State of Illinois and Statutes of the State of Illinois and empowered by statutes; and

WHEREAS, in the opinion of the corporate authorities of the Village of Vernon Hills, it is no longer necessary or useful to or for the best interests of the Village to retain a 1996 International 4900 cab/chassis now owned by it; and

WHEREAS, the 1996 International 4900 cab/chassis was placed for bid as a trade-in; and

WHEREAS, Village staff determined the amount offered was insufficient based on the Village Staff's opinion of value; and

WHEREAS, the Village now has a potential buyer for the 1996 International 4900 cab/chassis that is more in line with the Village's perceived value of the truck chassis; and

WHEREAS, the 1996 International 4900 cab/chassis is located in Indiana and it will cost the Village additional money to be returned to Vernon Hills if it is not sold in Indiana; and

WHEREAS, the Village Board of Trustees deem it appropriate to sell the 1996 International 4900 cab/chassis as it is not useful to the Village in its present state.

THEREFORE, BE IT ORDAINED, by the President and Village Board of Trustees of the Village of Vernon Hills, Illinois, as follows:

SECTION 1: The foregoing recitals are incorporated herein as findings of the Corporate Authorities.

SECTION 2: Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4) the Corporate Authorities find that the sale of the 1996 International 4900 cab/chassis, now owned by the Village, is no longer necessary or useful to the Village and it is in the best interest of the Village to sell this equipment.

SECTION 3: Pursuant to said Section 11-76-4, the Village Manager be and is hereby authorized and directed to sell the 1996 International 4900 cab/chassis to Delphi Body Works, 313 S. Washington, Delphi, IN 46923 for the sum of \$6500.

SECTION 4: This Ordinance shall be in full force and effect from and after its adoption as provided by law.


SECTION 5: ORDINANCE NUMBER. This ordinance shall be known as Ordinance Number 2014-013.


