

RESOLUTION 2016-136

A RESOLUTION WAIVING THE COMPETITIVE BIDDING PROCESS, AND AUTHORIZING THE VILLAGE BOARD TO ACCEPT PROPOSALS FOR SNOW AND ICE CONTROL SERVICES FROM ACRES GROUP, APEX LANDSCAPING, ARROW SHOP, BRIGHTVIEW, SCHROEDER & SCHROEDER, JAMES MARTIN AND ASSOCIATES, AND VERNON TOWNSHIP FOR THE 2016-17 WINTER SEASON; NOT TO EXCEED \$114,240

WHEREAS, the Village received proposals from Acres Group, Apex Landscaping, Arrow Shop, BrightView (formerly Brickman Group), Schroeder & Schroeder, James Martin and Associates, and Vernon Township to provide snow and ice control services during the 2016-17 Winter season; and

WHEREAS, the above mentioned contractors have all provided the Village with satisfactory snow and ice control services in the past, and are familiar with the scope of work; and

WHEREAS, the following is a cost comparison between the 2015-16 season, and the proposed 2016-17 season based upon the amount of snowfall per occurrence; and/or the accumulative snowfall for the entire season as described in each proposal; and

WHEREAS, all contracts will be for a one (1) year term with the exception of James Martin and Associates, which is for three (3) years extending through 2016-17, and there will be a 0% cost increase for the 2016-17 season for cul-de-sacs; and 1.5% increase for the Metra Station; and

WHEREAS, funds are budgeted within the FY2016-17 street contractual services account (0102040-520630), and the Metra street contractual services account (0909085-520630) for the snow removal of streets, cul-de-sacs, and sidewalks by all said contractors.

NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

THAT, the Village Board waives the competitive bidding process and the Village Manager is authorized to sign contracts for snow and ice control services with Acres Group, Apex Landscaping, Arrow Shop, BrightView, Schroeder & Schroeder, James Martin and Associates, and Vernon Township for the 2016-17 Winter season; and

THAT, the Finance Director is authorized to process purchase orders and make payments to the said contractors in the amounts listed below; for an overall amount not to exceed \$114,240.
