**2. VILLAGE OF VERNON HILLS, 290 EVERGREEN DRIVE REQUESTS A CLASS “G”
LIQUOR LICENSE**

The Village of Vernon Hills requests a Class “G” liquor license for the Vernon Hills Days. The event will take place from Thursday, July 13, 2023 through Sunday, July 16, 2023. Subject to Final approval, we anticipate the hours of operation will be: Thursday, 6:00 pm – 11:00 pm, Friday, 6:00 pm – 1:00 am, Saturday, 9:00 am – 1:00 am, and Sunday, 9:00 am – 10:00 pm.

The approval would allow only BASSET trained volunteers to sell and serve beer and wine. The Village is also requesting that the \$100.00 fee be waived.
