

## RESOLUTION 2011-117

### **A RESOLUTION GRANTING APPROVAL TO OPERATE AN OUTDOOR MERCHANDISE DISPLAY AND SALES ESTABLISHMENT FOR THE MARIANO'S LOCATED AT 1720 NORTH MILWAUKEE AVENUE**

**WHEREAS**, Max Dickman, representing Mariano's located at 1720 North Milwaukee Avenue has submitted an outdoor establishment permit application and plan for authorization to display and sell merchandise outdoors including the use of an outdoor grill; and

**WHEREAS**, the application for an outdoor establishment permit also includes a one time request to operate a radio remote event on the front sidewalk; and

**WHEREAS**, the Board of Trustees of the Village of Vernon Hills, in 2010, approved Ordinance 2010-049, amending Ordinance 2000-61 that outlines the permitting requirements and operating standards for the outdoor display and sale of landscape materials, requiring business owners to seek approval from the Board of Trustees prior to operating such Outdoor Establishments; and

**WHEREAS**, the Board of Trustees, having reviewed and considered Mariano's outdoor establishment permit application and plan including a request to conduct a radio remote, at its meeting on July 6, 2011, found that the application and plan sufficiently comply with the operational requirements and standards of Ordinance 2000-61 and which, in its judgment, would justify it in recommending approval of an outdoor establishment permit; and

**NOW, THEREFORE, BE IT RESOLVED** by the Village President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois, that the Village of Vernon Hills will allow Mariano's to operate an outdoor merchandise display and sales establishment, including approval to conduct a radio remote, conditioned upon:

1. The Merchandise and Display area shall be in accordance with the application and site plan, dated May 27, 2011.
2. Merchandise shall be displayed only within the blue shaded areas of the sidewalk in front of the store, as represented on the site plan prepared by Bradford Reality, dated May 27, 2011.
3. The use of an outdoor grill is hereby granted temporary approval. The grill shall be located within the blue shaded areas of the front sidewalk and shall be used on weekends only; not to exceed twenty five weekends in calendar year 2011.
4. The radio remote is approved as a one time event and shall take place on Friday, July 15, 2011 and be located on the side walk in front of the store (Within the blue shaded area)
