

**VILLAGE OF VERNON HILLS  
RESOLUTION 2025-011R**

**A RESOLUTION GRANTING APPROVAL OF AN  
OUTDOOR SPECIAL EVENT, CIRCUS VAZQUEZ, AT HAWTHORN MALL**

**WHEREAS**, the Village of Vernon Hills has received a special event application from Circo Hermanos Vazques, dba Circus Vazquez, to operate a circus in a large tent at the northwest corner of the Hawthorn Mall property from May 2, 2025 to May 12, 2025; and

**WHEREAS**, Section 13-7-6 of the Zoning Code authorizes the Village Board to approve outdoor uses within the B-1 General Business District; and

**WHEREAS**, the Board of Trustees, on review of the application at its meeting on March 18, 2024, finds the application and plan comply with Section 13-7-6 of the Zoning Code, and that approval the request is therefore justified.

**NOW, THEREFORE**, be it resolved by the President and Board of Trustees of the Village of Vernon Hills, that the Special Event Permit for Hawthorn Mall to operate an outdoor special event is hereby granted, subject to the following conditions:

1. The configuration of the event shall be in substantial conformance with the plans illustrated in Exhibit A;
2. The event organizers are responsible for confirming that food vendors have obtained appropriate licenses for food service;
3. The event organizers shall coordinate with the Vernon Hills Police Department to confirm that the security staffing level is appropriate; organizers will pay the rate determined by the Village should off duty police officers provide supplemental security;
4. The maximum attendance at any given show shall be as determined by the Fire Marshal;
5. Garbage receptacles shall be provided and the grounds shall be cleaned immediately after the event each day; and
6. The site shall be kept secure overnight, with no public access to the grounds or tent.


**Below is information regarding setup dates, show dates and show times

- Dates:
  - Set up: 4/29/25 to 5/2/25 : 8 am to 8 pm.
  - Shows: 5/2/25 to 5/12/25
    - Mon-Fri: 7:00-9:00 PM 1 show. Doors open at 6:30 pm and tent is closed at 9:30.
    - Sat/Sun: 1:00 - 3:00 PM 4:00-6:00 PM, 7:00-9:00 PM 3 shows.
  - Tear Down: 5/13/25 by 10 PM
- Set up:
  - 144' diameter circus tent.
  - Capacity of tent is 1800.
  - We have 8 certified crowd managers on site.
  - Tent is Flame Resistant: Certificate Attached.
  - Concessions: Permit has been submitted to the county.
  - Will apply for temporary business license.
  - Portable toilets will be provided on site. One ADA accessible will be provided.
  - Will need a hydrant meter from the Village of Vernon Hills Water Dept.
  - 30 yard trash bin on site and will be picked up by contracted company on demand.
  - 24 hour security on site.
  - 8' perimeter fence around the event. No public access allowed except during show time.
  - No animals are part of our circus.
