We have audited the financial statements of the governmental activities, the business-type activities, each major fund, the aggregate remaining fund information of the **Village of Vernon Hills, Illinois**, (Village), as of and for the year ended April 30, 2025, and the related notes to the financial statements, and have issued our report thereon dated October 16, 2025. We conducted our audit in accordance with auditing standards generally accepted in the United States of America.

In connection with our audit, nothing came to our attention that caused us to believe that the Village failed to comply with provisions of Subsection (q) of Section 1-74.4-3 of Public Act 85-1142, *An Act in Relation to Tax Increment Financing*, insofar as it relates to the accounting matters for the **TIF #2 Milwaukee Avenue/Townline Road TIF District of the Village of Vernon Hills, Illinois**. However, our audit was not directed primarily toward obtaining knowledge of such noncompliance. Accordingly, had we performed additional procedures, other matters may have come to our attention regarding the Village's noncompliance with the above-referenced statute, insofar as it relates to accounting matters.

This report is intended solely for the information and use of management, the Village Mayor, the Board of Trustees, and the State of Illinois and is not intended to be and should not be, used by anyone other than these specified parties.
