

**VILLAGE OF VERNON HILLS
RESOLUTION 2025-064**

**A RESOLUTION ESTABLISHING THE 2026 RATE SCHEDULE FOR
THE VERNON HILLS GOLF COURSE**

WHEREAS, the President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois have determined that, for administrative and ease of reference purposes, it is appropriate to adopt an Annual Rate Schedule (“Schedule”) for the Vernon Hills Golf Course (“Golf Course”), which Schedule shall provide a listing of certain daily and seasonal pass fees for the use of the Golf Course by both residents and non-residents; and

WHEREAS, the President and Board of Trustees have determined that it is appropriate to annually examine the financial status of the Golf Course to determine if the previously approved Schedule should be amended; and

WHEREAS, the President and Board of Trustees have determined that this Resolution would serve and be in the best interest of the Village of Vernon Hills.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois, as follows:

SECTION 1: Recitals. The foregoing recitals are incorporated herein as findings of the President and Board of Trustees.

SECTION 2: 2025 Annual Rate Schedule. The 2026 Annual Rate Schedule for the Vernon Hills Golf Course, attached hereto as EXHIBIT A, is hereby approved. This Resolution shall be known as the "Annual Rate Schedule" for the Vernon Hills Golf Course while it is in full force and effect as provided herein.

SECTION 3: Conflicts. All ordinances or resolutions, or parts of ordinances or resolutions, in conflict with the provisions of this Resolution, to the extent of such conflict, are repealed.

SECTION 4: Effective Date. It is intended that the fees, charges, and rates set forth herein will be reviewed periodically by the Board of Trustees. Accordingly, some or all of the provisions of this Resolution may be amended from time to time. This Resolution shall be effective upon its adoption, approval, and publication in the manner required by law. Each provision of this Resolution shall remain in full force and effect unless otherwise expressly provided or expressly amended by subsequent ordinance or resolution, in which case the amended provision shall be immediately effective.


