

**VILLAGE OF VERNON HILLS
ORDINANCE 2026-013**

AN ORDINANCE AUTHORIZING EXPENDITURES OVER \$25,000 TO CLARKE MOSQUITO MANAGEMENT, INC. TO PROVIDE MOSQUITO ABATEMENT SERVICES WITHIN FY2027 FOR AN AMOUNT NOT TO EXCEED \$66,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois ("*the Village*") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Ordinance 2025-026 authorized the Village to enter into a 3-year contract from FY2026 through FY2028 with Clarke Mosquito Management, Inc. for the Village of Vernon Hills Environmental Mosquito Management Program; and

WHEREAS, the base contract price of \$65,966.55 for FY2027 includes four (4) Village-wide sprays, surveillance and monitoring, larval control, and some special event sprays; and

WHEREAS, Staff has budgeted \$66,000 for mosquito abatement services in FY2027 budget account (0102040-520610); and

WHEREAS, Staff seeks approval to authorize the Finance Director to execute payments to Clarke Mosquito Management, Inc. to provide Environmental Mosquito Management abatement services in FY2027 for an amount not to exceed \$66,000.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is authorized to execute payments to Clarke Mosquito Management, Inc. for Environmental Mosquito Management services for an amount not to exceed \$66,000 in FY2027.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2026-013.


