

**RESOLUTION 2010-121**

**A RESOLUTION AMENDING RESOLUTION 2010-042 INCREASING PURCHASE ORDER 2011-116 TO LAKE COUNTY DEPARTMENT OF PUBLIC WORKS FOR WATER AND SEWER USAGE AT THE ARBORTHEATER IN THE AMOUNT OF \$275**

WHEREAS, Lake County Department of Public Works is considered a source determined by the Village Manager to be beneficial to the Village as a supplier of water/sewer for the Village of Vernon Hills; and

WHEREAS, the Village Board approved the 2010/2011 budget, which delineated potable water/sewer/irrigation in the following Public Works Department accounts:

WHEREAS, purchase order 2011-116 was processed in the amount of \$800 under account 0102081-520070 to Lake County Department of Public Works for water and sewer usage at the Arbortheater; and

WHEREAS, the amount of water and sewer usage thus far at the Arbortheater has been greater than anticipated, hence, causing payments to increase; and

WHEREAS, an additional \$275 is now needed to cover the water and sewer expenses at the Arbortheater for the remainder of the 2010-2011 budget year; and

WHEREAS, funds are available in account 0102081-520070 to increase purchase order 2011-116 to Lake County Department of Public Works.

**NOW THEREFORE BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:**

THAT, the Finance Director is authorized to increase purchase order 2011-116 to Lake County Department of Public Works in the amount of \$275, and the Village Manager is authorized to execute payments to Lake County Department of Public Works throughout the remainder of the 2010/2011 budget year.


