

RESOLUTION 2009-189

A RESOLUTION WAIVING THE COMPETITIVE BIDDING PROCESS, AUTHORIZING THE VILLAGE BOARD TO ACCEPT PROPOSALS FROM JAMES MARTIN ASSOCIATES, INC., BRICKMAN, ASPEN LANDSCAPES, INC., THE ARROW SHOP, AND ACRES GROUP FOR SNOW REMOVAL OF CUL-DE-SACS AND THE METRA STATION PARKING LOTS AND SIDEWALKS, AND TO ISSUE PURCHASE ORDERS TO THE SERVICE PROVIDERS BASED ON THE PROPOSALS NOT TO EXCEED \$80,290

WHEREAS, James Martin Associates, Inc., The Arrow Shop, Acres Group, and Aspen Landscaping provided snow and ice control service in 2008/09 and are familiar with the scope of work; and

WHEREAS, James Martin Associates, Inc. has submitted proposals for plowing of 106 cul-de-sacs, and plowing and sidewalk snow removal of the Metra Station Parking Complex; and

WHEREAS, The Arrow Shop has submitted a proposal for snow removal of the Bay Tree Court and Harvey Lake Drive cul-de-sacs; and

WHEREAS, Acres Group has submitted a proposal for snow removal of Shadow Creek Drive and Shadow Creek Circle and their cul-de-sacs; and

WHEREAS, Aspen Landscaping submitted a proposal for snow removal of Bloomfield Court and cul-de-sac; and

WHEREAS, Brickman submitted a proposal for snow removal of the Grosse Pointe Circle cul-de-sacs (7); and

WHEREAS, funds are budgeted in FY 09-10 street contractual services (0102040-520630) for the snow removal of streets and cul-de-sacs as well as sidewalk snow removal.

NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

The Village Board waives competitive bidding process and the Village Manager is authorized to sign contracts, issue purchase orders to James Martin Associates, Inc. for \$63,790, the Arrow Shop for \$4,000, Acres Group for \$4,000, Brickman for \$6,000 and Aspen Landscaping for \$2,500 and to make payments in accordance with the proposals and contracts; and

That, the Finance Department is authorized to make payments to the above listed vendors in an amount not to exceed \$80,290.




