AN ORDINANCE GRANTING VARIATIONS FROM THE SIGN CODE FOR HOBBY LOBBY, 290 HAWTHORN VILLAGE COMMONS, VERNON HILLS, IL, LAKE COUNTY

AN ORDINANCE GRANTING VARIATIONS FROM THE SIGN CODE FOR HOBBY LOBBY, 290 HAWTHORN VILLAGE COMMONS, VERNON HILLS, IL, LAKE COUNTY

WHEREAS, Hobby Lobby, located at 290 Hawthorn Village Commons Vernon Hills, IL, filed an application on August 29, 2012 requesting a variation from the Village Code of Ordinances, Chapter 19, Signs, Section 19-3(c)(6) to allow five (5) wall signs in lieu of the maximum permitted number of one (1) and Section 19-3(c)(6) to allow the cumulative total of the wall signs to be 302 square feet in lieu of the maximum permitted size of 208 square feet; and

WHEREAS, A public hearing was conducted on this application by the Zoning Board of Appeals at its meeting of September 20, 2012, after due notice thereof by publication, mailing and posting of the property; and

WHEREAS, the Zoning Board of Appeals, having fully heard the testimony, found that sufficient facts were presented which, in its judgment, would justify recommending approval of the following variations:

- 1. Section 19-3(c)(6) to allow four (4) wall signs in lieu of the maximum permitted number of one (1)
- 2. Section 19-3(c)(6) to allow the cumulative total of the wall signs to be 279.3 square feet in lieu of the maximum permitted size of 208 square feet; and

WHEREAS, the Village Board of Trustees have, with the findings of the Zoning Board of Appeals, found: 1) that the property in question cannot yield a reasonable return if required to be used only under the conditions allowed by the regulations of the code; 2) that the plight of the owner is due to unique circumstances; and 3) that variation if granted would not alter the essential character of the neighborhood.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE AND STATE OF ILLINOIS:

SECTION I. Pursuant to the Vernon Hills Sign Code, as amended, the following variations are hereby granted:

- 1. Section 19-3(c)(6) to allow four (4) wall signs in lieu of the maximum permitted number of one (1).
- 2. Section 19-3(c)(6) to allow the cumulative total of the wall signs to be 279.3 square feet in lieu of the maximum permitted size of 208 square feet.

SECTION II. Approvals of the variations are subject to the following conditions:

- 1. The Hobby Lobby signs shall be in substantial compliance with the elevation drawings prepared by Starlite Sign, dated September 17, 2012.
- 2. The signs reading "Crafts", "Seasonal", and "Home Accents" shall not be illuminated.

SECTION III. SEVERABILITY. In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

<u>SECTION IV. REPEAL AND SAVINGS CLAUSE</u>. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

<u>SECTION V. EFFECTIVE DATE.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

<u>SECTION VI.</u> <u>ORDINANCE NUMBER.</u> This ordinance shall be known as Ordinance Number 2012-058.
