AN ORDINANCE GRANTING FINAL APPROVALS FOR PROPERTY COMMONLY KNOWN AS VICTORY CENTRE OF VERNON HILLS LOCATED ON LOT 4, DEERPATH ATRIUM SUBDIVISION BEING THE SOUTHWEST CORNER OF THE INTERSECTION OF PHILLIP ROAD AND ATRIUM DRIVE, IN THE VILLAGE OF VERNON HILLS, LAKE COUNTY.

Published in pamphlet form by the Authority of the President and Board Of Trustees of the Village of Vernon Hills, Lake County, Illinois, this 21st Day of April 2010 AN ORDINANCE GRANTING FINAL APPROVALS FOR PROPERTY COMMONLY KNOWN AS VICTORY CENTRE OF VERNON HILLS LOCATED ON LOT 4, DEERPATH ATRIUM SUBDIVISION BEING THE SOUTHWEST CORNER OF THE INTERSECTION OF PHILLIP ROAD AND ATRIUM DRIVE, IN THE VILLAGE OF VERNON HILLS, LAKE COUNTY.

- WHEREAS, Robert H. Helle, representing Vernon Hills SA Associates, L.P., in regards to property legally described in Exhibit A, has petitioned the Village of Vernon Hills for approval of final site and landscaping plans and architectural elevations for the legally described property to be known as "Victory Centre of Vernon Hills"
- WHEREAS, the requested approvals would be in general compliance with the final plans of the Victory Centre of Vernon Hills Village Board Booklet prepared by HKM Architects & Planners and attached hereto as Exhibit B.
- WHEREAS, after the public meeting held March 17, 2010 and continued from time to time by the Planning and Zoning Commission of the Village of Vernon Hills, and pursuant to the Vernon Hills Zoning Ordinance of 1982, as amended, said Planning and Zoning Commission has filed its report concerning said petition as listed above and recommended approval of final site and landscaping plans and building elevations for the proposed affordable senior housing project known as Victory Centre of Vernon Hills subject to certain conditions.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE AND STATE OF ILLINOIS:

SECTION I. Pursuant to the Vernon Hills Zoning Ordinance of 1982, the final site and landscaping plans and architectural elevations for the entire project, as setforth in Exhibit B, are hereby approved subject to the conditions listed in Section II.

**SECTION II.** Pursuant to the Vernon Hills Zoning Ordinance of 1982, as amended, and the recommendations of the Planning and Zoning Commission, the Conditions of Approval, as set forth in Exhibit C, are hereby approved and are made a part of the approvals as listed in the Section above.

**SECTION III. SEVERABILITY.** In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of

competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

SECTION IV. REPEAL AND SAVINGS CLAUSE. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

SECTION V. SUCCESSORS AND ASSIGNS. All of the provisions of this Ordinance and the attachments hereto are binding on all successors and assigns of Vernon Hills SA Associates, L.P.

<u>SECTION VI. EFFECTIVE DATE.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

<u>SECTION VII.</u> <u>ORDINANCE NUMBER.</u> This ordinance shall be known as Ordinance Number 2010-030.
