

RESOLUTION 2013-048

A RESOLUTION AUTHORIZING AN EXECUTION OF A THREE YEAR CONTRACT WITH CLARKE MOSQUITO MANAGEMENT, INC. FOR ENVIRONMENTAL MOSQUITO MANAGEMENT SERVICES FROM FY2013-FY2015

WHEREAS, the Village of Vernon Hills entered into an agreement on January 20, 2004 with Clarke Mosquito Management, Inc. for the Village of Vernon Hills Environmental Mosquito Management Program; and

WHEREAS, Clarke Mosquito Management, Inc. is proposing a three year contract from FY2013 through FY2015 with no cost increase from FY2012 for FY2013; and

WHEREAS, the contract allows for Clarke Mosquito Management to increase the cost for services for FY2014 and FY2015 if needed, by a percentage which shall not exceed the lesser of the percentage increase of the consumer price index (CPI) or a maximum of 5% (Price Increase Percentage); and

WHEREAS, the Village Board has approved the 2013/2014 budget that delineates \$58,930 for insect control services under account 0102040-520610; and

WHEREAS, the base cost for the 2013 Environmental Mosquito Management Program is \$54,810; and

WHEREAS, Surveillance and Monitoring; including one New Jersey light trap and one oviposition or gravid trap is included in the cost; and

WHEREAS, larval control includes three inspections of 130 sites, six targeted inspections of 64 sites, and three Culex targeted inspections of 40 sites, and four treatments of 2500 catch basins; and

WHEREAS, the cost for 2013 Ultra Low Volume (ULV) Treatments using Mosquitomist, four (4) community wide, July 4th, and the Summer Celebration is included in the above cost; and

WHEREAS, the cost for an additional community wide ULV Treatment will be billed at \$4,935; and

WHEREAS, the ULV treatment cost for Arborthheater events and other special events is estimated at \$200 per special event.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

THAT, the Village Manager is authorized to execute a three year contract with Clarke Mosquito Management, Inc. for FY2013 through FY2015; and

THAT, the Finance Director is authorized to execute payments to Clarke Mosquito Management, Inc. for the Village of Vernon Hills 2013 Environmental Mosquito Management Program in an amount not to exceed \$58,000.




