

**RESOLUTION 2013-063**

**A RESOLUTION AWARDDING THE FURNISH AND DELIVER FUEL BID TO PETROLEUM TRADERS CORP FOR THE PURCHASE OF GASOLINE AND DIESEL FUEL FOR A TWO YEAR PERIOD FROM 2013-2015**

**WHEREAS**, the Village of Vernon Hills Public Works Department budgeted \$202,930 for the purchase of gasoline and diesel fuel in account: 0102040-530140 for the 2013/14 budget year; and

**WHEREAS**, Community School District #128, Cook Memorial Library, Countryside Fire Protection District, and the MEG Unit all purchase fuel from the Village; and each user reimburses an additional \$.08 surcharge per gallon of usage each month; and

**WHEREAS**, bids for the purchase and delivery of fuel from 2013-2015 were opened on March 27, 2013 and received from Olsen Service (Fox Lake, IL), Avalon Petroleum (Kankakee, IL), Petroleum Traders Corporation (Ft. Wayne, IN), RKA Petroleum (Romulus, MI), and Bell Fuels (Cicero, IL.); and

**WHEREAS**, the lowest bid was submitted by Petroleum Traders Corp.; and

**WHEREAS**, providing Petroleum Traders Corp. meets the Village's insurance requirements, they will be determined to be the best-qualified bidder to provide gasoline and diesel fuel for the two year period.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:**

**THAT**, the contract be awarded to Petroleum Traders Corp. for the purchase of gasoline and diesel fuel for a two year period beginning May 1, 2013 and ending April 30, 2015; and

**THAT**, the Village Manager is authorized to execute a contract and commit the Village to make payments to Petroleum Traders Corp.; and

**THAT**, the Finance Director is authorized to execute a purchase order to Petroleum Traders Corp. for FY2013-14 and FY2014-15; and

**THAT**, the Finance Director is authorized to increase the FY2013-14 and FY2014-15 purchase orders to Petroleum Traders Corp. with monies reimbursed by outside users.


