

RESOLUTION 2014-083

A RESOLUTION GRANTING APPROVAL TO OPERATE AN OUTDOOR SPECIAL EVENT FOR NORTH AMERICAN MIDWAY ENTERTAINMENT LOCATED AT 122 HAWTHORN CENTER

WHEREAS, Ed Dame, representing North American Midway Entertainment on behalf of Westfield Hawthorn Mall, 122 Hawthorn Center has submitted an Outdoor Establishment permit application and plan for authorization to operate a special event; and

WHEREAS, the property, as described herein is located within the B-1, General Business District; and

WHEREAS, Section 13.7.6 of the Zoning Code authorizes the Village Board to approve outdoor uses within the B-1 General Business District; and.

WHEREAS, the Board of Trustees, at their meeting on April 15, 2014 having reviewed and considered the request for an outdoor special event, found that the application and plan sufficiently comply with Section 13.7.6 of the Zoning Code and which, in its judgment, would justify it in recommending approval of the Outdoor special event.

NOW, THEREFORE, BE IT RESOLVED by the Village President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois, that the Village of Vernon Hills will allow North American Midway Entertainment to operate an outdoor special event, conditioned upon:

1. The special event will take place from Wednesday, May 14, 2014 through Sunday, May 18, 2014.
2. The permitted hours of operation shall be: Wednesday 6:00 pm – 10:00 pm; Thursday 6:00 pm – 10:00 pm; Friday 6:00 pm – 11:00 pm; Saturday 2:00 pm – 11:00 pm; and Sunday 2:00 pm – 10:00 pm.
3. The Village reserves the right to close off portions of Ring Road for the purpose of creating a pedestrian crossing.
4. North American Midway Entertainment is required to submit a list of all employees working at the carnival to the Vernon Hills Police Department at least seven (7) days in advance of the event.
5. The Village, at its discretion, may require North American Midway Entertainment to hire two (2) off duty Vernon Hills' police officers to be on site during the operating hours of the carnival. North American Midway Entertainment shall be responsible to pay the cost of the officers at a rate determined by the Village.
6. Compliance with the application and site plan dated March 19, 2014.

7. Garbage receptacles shall be provided and the general vicinity shall be cleaned immediately following each day of the event.


