

**RESOLUTION 2014 - 116**

**A RESOLUTION AMENDING RESOLUTION 2014-103 TO ADJUST THE  
CURRENT WAGES OF CERTAIN NON-UNION POSITIONS OF THE  
VILLAGE OF VERNON HILLS**

WHEREAS, the Village Board believes it is appropriate for there to be a 2.75% increase adjustment to the wages of certain non-union positions of the Village of Vernon Hills effective May 1, 2014; and

WHEREAS, the Village Board has determined that the Step Schedule of the Village of Vernon Hills Pay Plan be included within the Village of Vernon Hills Personnel Manual; and

WHEREAS, the Board approved Resolution 2014-103 at its June 3, 2014 meeting granting salary range adjustments for certain non-union positions; and

WHEREAS, Resolution 2014-103 is hereby amended to include the part-time Administrative Assistant I, Crime Prevention Officer, and Electrical Inspector positions not included in Resolution 2014-103.

NOW THEREFORE BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:


