

**RESOLUTION 2014-118**

**A RESOLUTION AMENDING RESOLUTION 2014-067 AUTHORIZING APPROVAL TO INCREASE EXPENDITURES FROM \$55,000 TO \$62,000 TO DRAKE PAINTING & WALLPAPERING CO. FOR PAINTING SERVICES AT VARIOUS MUNICIPAL PROPERTIES WITHIN FISCAL YEAR 2015**

WHEREAS, the Village of Vernon Hills maintains eight (8) buildings that require interior & exterior painting and staining as needed; and

WHEREAS, the Village Board approved Resolution 2014-067 authorizing payment within Fiscal Year 2015 to Drake Painting & Wallpapering Co. for painting & staining services at four (4) buildings as shown; and

WHEREAS, Drake Painting & Wallpapering Co. will also provide painting services at the Vernon Hills Golf Course. Therefore, Resolution 2014-067 requires an amendment. Staff also received improved pricing at the Arboretheater (-\$8,960), and the contractor has since added painting of the Village's monument signs for an amount of \$6,300; meanwhile, eliminating the painting all together at the Police Department Building (\$1,000) due to projected renovations; and

WHEREAS, Staff is requesting approval from the Village Board to amend Resolution 2014-067 and authorize additions to the locations and costs for painting and staining services performed by Drake Painting and Wallpapering Co. within Fiscal Year 2015; and

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

THAT, Drake Painting and Wallpapering Co. is authorized to perform painting and staining within Fiscal Year 2015 at the Village Hall, Arboretheater, VHAC, Golf Course, and Monument Signs; and

THAT, the Finance Director is authorized to increase Street Maintenance Services account

(0102051-520600) in the amount of \$6,300 for painting of the monument signs via a budget transfer with funds currently found within the Public Works FY2014-15 budget; and

THAT, the Finance Director is authorized to execute payments to Drake Painting & Wallpapering Co. within Fiscal Year 2015 in an amount not to exceed \$62,000 for all said work.


