

RESOLUTION 2014-170

A RESOLUTION AMENDING RESOLUTION 2014-026 AUTHORIZING AN INCREASE IN PAYMENT TO MILIEU DESIGN FOR THE GENERAL LANDSCAPE MAINTENANCE OF VILLAGE PROPERTY FOR THE 2014-15 SEASON FROM \$46,000 TO \$56,500

WHEREAS, Resolution 2014-026, approved March 19, 2014, authorized the Public Works Department to extend the existing contract for general landscape maintenance of Village property and public R.O.W. for the 2014-15 season with Milieu Design for the amount of \$46,000; and

WHEREAS, to utilize staff's skills and time more effectively, mowing and landscaping of the Public Works Department grounds was added as an addition to Milieu's responsibilities; therefore, increasing the initial cost of \$46,000 for landscape maintenance services for the 2014-15 seasons; and

WHEREAS, staff had also anticipated lesser mowings in the Summer months due to previous dry summers; however, this summer was wet, causing mowing to be more frequent; hence, also increasing the initial cost of \$46,000 for landscape maintenance services for the 2014-15 seasons; and

WHEREAS, Milieu Design will begin spring landscape maintenance in April, 2015; prior to the new budget; which will require funds to be available; and

WHEREAS, staff is requesting approval to increase payment to Milieu Design LLC from \$46,000 to \$56,500 for the general landscape maintenance of Village property for the 2014-15 seasons; and

WHEREAS, the additional \$10,500 is available within the Public Works Grounds Services account (0102047-520600).

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

THAT, the Finance Director is authorized to increase payments to Milieu Design from \$46,000 to \$56,500 for general landscape maintenance on Village property for the 2014-15 seasons; and

THAT, the Finance Director is authorized to increase FY2014-15 purchase order #371 to Milieu Design LLC by \$10,500 with funds taken from Public Works Grounds Services account (0102047-520600).




