

RESOLUTION 2014-189

**A RESOLUTION AMENDING RESOLUTION 2014-139 AUTHORIZING AN INCREASE IN PAYMENT TO SCHROEDER ASPHALT SERVICES FOR THE 2014 BITUMINOUS PAVEMENT PATCHING PROGRAM (3rd YR RENEWAL) FROM \$90,000 TO \$90,483.59**

**WHEREAS**, the 2011-14 Bituminous Pavement Patching Program was publicly bid and opened on June 28, 2011 with Schroeder Asphalt Services, and subsequently awarded the multi-year contract for the 2011-14 seasons; and

**WHEREAS**, under Resolution 2014-139, the Village Board approved an amendment to Resolution 2014-032, authorizing payment to Schroeder Asphalt Services, Inc. to increase from \$60,000 to \$90,000 for additional pavement patching work to be completed under the 2014 Bituminous Pavement Patching Program in an effort to repair unanticipated damages caused by last winter's extreme frost conditions; and

**WHEREAS**, the final invoice for the additional pavement patching work exceeded the \$90,000 authorized by the Village Board to pay Schroeder Asphalt Service for all work completed under the 2014 Bituminous Pavement Patching Program by \$483.59; and

**WHEREAS**, the additional \$483.59 is available within the FY2014-15 budget account (0209059-550050); and

**WHEREAS**, staff is requesting approval to increase payment to Schroeder Asphalt Services from \$90,000 to \$90,483.59 to cover the overall cost for pavement patching work completed under the 2014 Bituminous Pavement Patching Program.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:**

**THAT**, the Finance Director is authorized to increase FY2014-15 purchase order #806 to Schroeder Asphalt Services, Inc. in the amount of \$483.59 from account (0209059-550050); and

**THAT**, the Finance Director is authorized to make payments to Schroeder Asphalt Services, Inc. for work completed under the 2014 Bituminous Pavement Patching Program in an amount not to exceed \$90,483.59.




