**AN ORDINANCE AUTHORIZING THE
EXECUTION OF AN AGREEMENT
BETWEEN THE VILLAGE OF VERNON
HILLS AND ILLINOIS FRATERNAL
ORDER OF POLICE LABOR COUNCIL**

WHEREAS, the Illinois Fraternal Order of Police Labor Council is the collective bargaining representative for Vernon Hills' Telecommunicators; and

WHEREAS, the Village of Vernon Hills and the Illinois Fraternal Order of Police Labor Council have negotiated a collective bargaining agreement; and

WHEREAS, the negotiating teams for the Village of Vernon Hills and the Illinois Fraternal Order of Police Labor Council have recommended approval of a proposed labor contract to the union membership and the Village Board.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois, that:

SECTION I. That the Village President is authorized to execute and Village Clerk to attest to an agreement between the Village of Vernon Hills and the Illinois Fraternal Order of Police Labor Council, said agreement pertaining to May 1, 2016 through April 30, 2019, in the form agreed upon by the parties.

SECTION II. SEVERABILITY. In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

SECTION III. REPEAL AND SAVINGS CLAUSE. All ordinances and resolutions or parts of ordinances and resolutions in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

SECTION IV. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.


SECTION V. ORDINANCE NUMBER. This ordinance shall be known as Ordinance Number 2017-018




