**ORDINANCE NO. 2017-026**

**AN ORDINANCE AWARDING THE 2017 BITUMINOUS PAVEMENT PATCHING PROGRAM BID AND CONTRACT TO SCHROEDER ASPHALT SERVICES FOR AN AMOUNT NOT TO EXCEED \$75,000**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village is responsible for maintaining all Village-owned properties, and Village rights of way (ROWs); including public streets; and

**WHEREAS**, to do so efficiently and effectively, the Village contracts out asphalt patching of damaged sections of pavement on various public streets on an annual basis; and

**WHEREAS**, the Village received a total of seven (7) sealed bids on March 23, 2017 for said pavement patching work; at which time they were publicly opened; and

**WHEREAS**, Schroeder Asphalt Services provided the lowest qualifying bid for the 2017 Bituminous Pavement Patching Program for a price of \$39,900; and

**WHEREAS**, \$75,000 is available within the FY2017-18 budget account (0209059-550050) for said work; and

**WHEREAS**, the contract allows for the Village to increase or decrease its proposed quantity of patching areas based on pricing; therefore, staff will be increasing its quantity of proposed locations since the bid price is well below the Village's budgeted amount; resulting in more areas of the Village that can be serviced and maintained while staying within the \$75,000 budget; and

**WHEREAS**, staff recommends addressing other distressed pavement areas due to the favorable bids and, therefore, the Ordinance amount is "Not to Exceed" \$75,000; and

**WHEREAS**, an Ordinance is required for the award of bids and/or contracts; and

**WHEREAS**, expenditures over \$20,000 require Board of Trustees approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute all required documents for the 2017 Bituminous Pavement Patching Program with Schroeder Asphalt Services for a price not to exceed \$75,000 within the 2017-18 Fiscal Year for said services.

**SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make payment to Schroeder Asphalt Services in an amount not to exceed \$75,000 per the attached bid tabulation in Exhibit A; in conjunction with a contingency of \$35,100 for additional quantities and locations to be added to the contract.

**SECTION 3: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2017-026.


