AN ORDINANCE AUTHORIZING A ONE-YEAR CONTRACT EXTENSION WITH SUPERIOR ROAD STRIPING FOR THE 2017 THERMOPLASTIC PAVEMENT LANE MARKING OF VILLAGE STREETS FOR AN AMOUNT NOT TO EXCEED \$40,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois ("the Village") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village is responsible for maintaining all Village-owned properties, and Village rights of way (ROWs); including public streets; and

WHEREAS, to do so efficiently and effectively, the Village contracts out pavement striping to be performed on various public streets on an annual basis; and

WHEREAS, the Village participated in the 2016 Northwest Municipal Conference Joint Bid for Thermoplastic Pavement Lane Marking; and

WHEREAS, Superior Road Striping provided the lowest qualifying bid per unit price; and

WHEREAS, Resolution 2016-038 awarded the bid to Superior Road Striping, and authorized a one-year contract extension for 2017; and

WHEREAS, \$40,000 is available within the FY2017-18 budget account (0209059-550050) for said work for 2017; and

WHEREAS, an Ordinance is required for the award of bids and/or contracts; and

WHEREAS, expenditures over \$20,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents for a one-year contract extension for the 2017 Thermoplastic Pavement Lane Marking with Superior Road Striping for a price not to exceed \$40,000 within the 2017-18 Fiscal Year for said services.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Superior Road Striping in an amount not to exceed \$40,000.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2017-028.
