



ORDINANCE 2017-021

AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO EZ GO FOR THE PURCHASE OF GOLF CARTS IN AN AMOUNT NOT TO EXCEED \$81,600

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village owns the Vernon Hills Municipal Golf Course (*"Golf Course"*); and

WHEREAS, the golf cart fleet at the Golf Course has now exceeded its useful life and must be replaced; and

WHEREAS, the Village obtained two competitive quotes to purchase these carts, and wishes to waive competitive bidding to take advantage of Kemper Management's corporate discount with EZ GO; and

WHEREAS, EZ GO provided the lowest quote for this equipment at \$81,600, which includes the Corporate Discount and ability to make payment in two installments; and

WHEREAS, expenditures over \$20,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents to purchase a golf cart fleet from EZ GO in a number not to exceed \$81,600.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to EZ GO in an amount not to exceed \$81,600 per the attached quote in Exhibit A, and release the payment prior to it appearing on the Board Invoice Approval List.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2017-021.


