



**VILLAGE OF VERNON HILLS  
ORDINANCE NO. 2017-039**

**AN ORDINANCE AUTHORIZING PAYMENT TO THE VERNON HILLS PARK DISTRICT IN THE AMOUNT OF \$25,000 FOR THE SULLIVAN WOODS IMPROVEMENTS**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village of Vernon Hills (*"Village"*) recognizes the Vernon Hills Park District's (*"Park District"*) role in operating and maintaining open park space within the Village; and

**WHEREAS**, the Park District and Village have determined that the condition of the stream along Sullivan Woods requires a cooperative approach to mitigate the blockage of the Seavey Drainage Ditch; and

**WHEREAS**, the Park District has existing contracts in the amount of \$20,000 and has committed to spend additional funds in 2017; and

**WHEREAS**, the Village agreed to donate \$25,000 to the Park District to offset a portion of the reconstruction costs; and

**WHEREAS**, the Village included said \$25,000 in the FY16-17 budget under Stormwater Projects (account #0209111 550030) titled Sullivan Woods Fallen Tree Removal; and

**WHEREAS**, the Village Board of Trustees has determined that the donation of these funds is in the best interest of the community.

**WHEREAS**, all expenditures over \$20,000 require Board of Trustees approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is authorized to pay the Vernon Hills Park District for this contribution for reconstruction costs from the Capital Sub-Fund Stormwater Projects Account, (0209111 550030) in an amount of \$25,000; and

THAT, the Finance Department is authorized to release the \$25,000 payment to Park District prior to the payment appearing on the Invoice Approval Report.

**SECTION 2: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2017-039.


