





ORDINANCE NO. 2017-040

AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES OVER \$20,000 TO COMMONWEALTH EDISON WITHIN THE FY2017-18 BUDGET YEAR NOT TO EXCEED \$70,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois ("the Village") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Commonwealth Edison is considered a source determined by the Village Manager to be beneficial to the Village as a supplier of electricity for the Village of Vernon Hills; and

WHEREAS, the Village Board approved the FY2017-18 budget which delineates electricity in the following accounts:

WHEREAS, expenditures over \$20,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is authorized to make payment to Commonwealth Edison for electrical service throughout the FY2017-18 budget year in an amount not to exceed \$70,000; and

THAT, the Finance Director is authorized to apply re-imbusement monies from outside field users of the Vernon Hills Athletic Complex (VHAC) to the Vernon Hills Athletic Complex electricity account (0102114-520050), and increase the FY2017-18 purchase order to Commonwealth Edison from the VHAC electricity account (0102114-520050) as necessary.

**SECTION 2: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2017-040.




