



**AN ORDINANCE AUTHORIZING APPROVAL OF ENTERTAINMENT CONTRACTS FOR THE ARBORTHEATER SUMMER CONCERT SERIES IN AN AMOUNT NOT TO EXCEED \$6,000**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village of Vernon Hills sponsors a free outdoor concert series at the Vernon Hills Memorial Arboretheater during the summer; and

WHEREAS, the Village works with Bass & Schuler’s Entertainment to procure entertainment for the concert series; and

WHEREAS, the following bands were selected for the dates noted below and at the amount shown.

June 22, 2017	Generation	\$1,200
June 29, 2017	Rockstar Rodeo	\$1,200
July 20, 2017	Final Say	\$1,200
July 27, 2017	Saturday June Band	\$1,200
August 3, 2017	Dueling Pianos	\$1,200

WHEREAS, all expenditures require Board of Trustees approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute all required documents to purchase the summer concert series entertainment at a price not to exceed \$6,000.

**SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make payment to the selected bands in an amount not to exceed \$6,000 total per the attached contracts in Exhibit A.

**SECTION 3: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2017-035.




