



AN ORDINANCE AUTHORIZING APPROVAL OF ENTERTAINMENT CONTRACTS FOR THE JULY 4, 2017 PARADE AND EVENING EVENTS IN AN AMOUNT NOT TO EXCEED \$12,870

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois ("the Village") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village of Vernon Hills hosts the July 4<sup>th</sup> parade and evening entertainment in the park; and

WHEREAS, the Village works with numerous entertainers to procure entertainment for the parade and evening events; and

WHEREAS, the following bands and entertainers were selected at the amount shown below.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute all required documents to purchase the entertainers for the July 4<sup>th</sup> Parade and evening events at a price not to exceed \$12,870.

**SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make payments to the selected entertainers in an amount not to exceed \$\$12,870 total per the attached contracts in Exhibit A.

**SECTION 3: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2017-037.




