



AN ORDINANCE AUTHORIZING THE PAYMENT TO THE VERNON HILLS PARK DISTRICT IN THE AMOUNT OF \$100,000 FOR THE KIDS CASTLE PROJECT

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village of Vernon Hills ("Village") recognizes the Vernon Hills Park District's ("Park District") role in operating and maintaining open park space within the Village; and

WHEREAS, the Park District has determined that the Kids Castle Playground ("Kids Castle") in Deerpath Park, is in need of reconstruction; and

WHEREAS, the total reconstruction cost of Kids Castle is estimated to be \$600,000; and

WHEREAS, Budget Ordinance 2017-030 authorized the second and final donation installment to the Park District of \$100,000 to offset a portion of the reconstruction costs; and

WHEREAS, the Village Board of Trustees has determined that the donation of these funds is in the best interest of the community.

WHEREAS, expenditures over \$20,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to issue payment to the Vernon Hills Park District for this contribution for reconstruction costs from the Capital Sub-Fund Remodeling/Renovation Account, (0209109-550040) for with an amount not to exceed \$100,000 and release the payment to Park District prior to the payment appearing on the Invoice Approval Report.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2017-055.
