AN ORDINANCE AUTHORIZING APPROVAL TO WAIVE THE COMPETITIVE BIDDING PROCESS AND APPROVAL OF A CONTRACT WITH CLARKE AQUATIC SERVICES, INC. FOR AQUATIC WEED AND ALGAE CONTROL SERVICES OF VARIOUS PONDS FOR AN AMOUNT NOT TO EXCEED \$33,204

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village currently budgets funds within budget account (0102047-520600) to provide algae control services to the following Village maintained pond locations for a proposed amount of \$18,054 for FY2017-18; and

WHEREAS, the Village also instituted an Adopt-A-Pond Program for residents to participate in and share 50% of the treatment costs with the Village to address algae issues occurring in seventeen (17) additional ponds not being treated under the Village's current program; and

WHEREAS, the Village has budgeted an additional \$5,000 to allocate towards shared costs between the Village and residents for said program; and

WHEREAS, the additional pond locations of concern are primarily adjacent to White Deer Run; including Pebble Beach and Beaver Creek ponds; and

WHEREAS, White Deer Run has agreed to participate in the Adopt-A-Pond Program by treating 3-4 of the pond locations adjacent to their property by contributing \$4,800 towards treatment costs; and

WHEREAS, Village staff has reached out to Clarke Aquatic Services, Inc. for a proposal to treat all seventeen (17) additional ponds that are included within the Adopt-A-Pond Program (with the exception of the Pointe North Pond and marsh downstream of Lake Charles); and

WHEREAS, Clarke Aquatic Services, Inc. advised the Village that by treating a greater number of ponds, and treating the ponds early in the season, would be more effective and efficient for their operations; therefore, allowing them to offer the Village special pricing for said work in the amount of \$15,150 for early treatment of all seventeen (17) ponds; and

WHEREAS, Clarke Aquatic Services, Inc. has provided the Village aquatic weed and algae control services for the past several years, and is very familiar with the scope of work and has done satisfactory work; and

WHEREAS, staff recommends waiving the competitive bidding process for aquatic weed control and algae services of Village owned ponds; and executing a one year contract with Clarke Aquatic Services, Inc. for an amount not to exceed \$33,204 for all the ponds currently being treated within the Village's annual program and the seventeen (17) additional ponds as part of the Adopt-A-Pond Program; and

WHEREAS, consolidated purchases throughout the budget year of over \$20,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents for aquatic weed and algae control services of Village ponds with Clarke Aquatic Services, Inc. at a price not to exceed \$33,204.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Clarke Aquatic Services, Inc. in an amount not to exceed \$33,204; and

Additionally, the Finance Director is authorized to take \$9,624 from the FY2016-17 budget account (0102047-520600); \$18,780 from the FY2017-18 budget account (0102047-520600); and the \$4,800 contribution from White Deer Run Golf Course to make said payment to Clarke Aquatic Services, Inc. within Fiscal Year 2017-18.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2017-058.


