AN ORDINANCE AUTHORIZING PAYMENT TO KLOSS DISTRIBUTORS FOR THE PROVISION OF ALCOHOLIC BEVERAGES TO BE SOLD AT THE FISCAL YEAR 2017 – 2018 SUMMER CELEBRATION CARNIVAL FOR AN AMOUNT NOT TO EXCEED \$25,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Kloss Distributors (*“Kloss”*) has been selected as the vendor to provide the Village of Vernon Hills (*“Village”*) with alcoholic beverages to be sold at the annual Summer Celebration Carnival; and

WHEREAS, the Village’s Summer Celebration Carnival will take place on July 13-16, 2017; and

WHEREAS, their payment will be based on their annual sales contract, which is projected to be no more than \$25,000 for the provision of beverages at the annual Summer Celebration Carnival; and

WHEREAS, all expenditures in excess of \$20,000 require Village Board approval; and

WHEREAS, this payment will be issued prior to the next Village Board Meeting on July 18, 2017.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:


SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: the Village Manager, Finance Director and Assistant to the Finance Director are authorized to make a payment to Kloss Distributors for an amount not to exceed \$25,000 upon receipt of documentation of the amount due and payable for beverages sold at the Summer Celebration Carnival and release the payment to Kloss Distributors prior to the payment appearing on the Invoice Approval Report.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.


SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2017-085.






