



**AN ORDINANCE AMENDING THE ANNUAL BUDGET OF  
THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE, STATE OF ILLINOIS,  
FOR THE FISCAL YEAR BEGINNING MAY 1, 2017 AND  
ENDING APRIL 30, 2018 IN THE AMOUNT OF \$4,216**

**WHEREAS**, by Ordinance No. 2017-030, the Village President and Board of Trustees of the Village of Vernon Hills ("*Village Board*"), Illinois adopted the Annual Budget of the Village of Vernon Hills for the fiscal year beginning May 1, 2017, and ending April 30, 2018; and

**WHEREAS**, the FY 2017-18 budget included a budget of \$3,000 for the Village Board Charitable Golf Course Event; and

**WHEREAS**, the event encountered unanticipated expenditures that require additional appropriation; and

**WHEREAS**, the Village Board has determined that it will serve and be in the best interest of the Village to adopt an Ordinance amending the Annual Budget.

**NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE BOARD OF VERNON HILLS, LAKE COUNTY, ILLINOIS**, as follows:

**SECTION 1: RECITALS.** The foregoing recitals are incorporated into, and made a part of, this Ordinance as the findings of the Village Board.

**SECTION 2: ADOPTION OF AMENDMENTS.** The Annual Budget shall be, and it is hereby, amended as follows:

**SECTION 3: PUBLICATION.** The Village Clerk is hereby directed to publish this Ordinance in pamphlet form pursuant to the Statutes of the State of Illinois.

**SECTION 4: EFFECTIVE DATE.** This Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner as provided by law.

**SECTION 5: ORDINANCE NUMBER.** This Ordinance shall be known as Ordinance Number 2017-098.


