

VILLAGE OF VERNON HILLS

ORDINANCE NO. 2017-116

AN ORDINANCE WAIVING THE COMPETITIVE BIDDING PROCESS AND AUTHORIZING THE VILLAGE TO EXECUTE A CONTRACT WITH MASONRY BY FERNANDO, INC. TO REMOVE AND REPLACE THE EXISTING CONCRETE RIBBON AND BRICK PAVERS AT THE ENTRANCES ONTO INVERNESS DRIVE, SHADOW CREEK CIRCLE, SHADOW CREEK DRIVE, AND HAZELTIME DRIVE IN GREGG'S LANDING FOR AN AMOUNT NOT TO EXCEED \$20,600

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village has budgeted funds within the 2017-18 Fiscal Year budget account (0102040-520630) for brick paver maintenance and replacement; and

WHEREAS, the following streets within the Gregg's Landing Subdivision currently have brick pavers within their R.O.W. entrances requiring replacement due to significant settling and cracking of the existing concrete ribbons and pavers: Inverness Drive, Shadow Creek Circle, Shadow Creek Drive, and Hazeltime Drive; and

WHEREAS, staff reached out to eight companies seeking proposals to include Prevailing Wage, and only two of the eight were able to do so; and

WHEREAS, Masonry by Fernando, Inc. provided the Village with the lowest priced proposal to remove and replace concrete ribbons and brick pavers at the above mentioned locations for an amount of \$20,600; and

WHEREAS, expenditures over \$20,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents for the removal and replacement of concrete ribbons and brick pavers within the R.O.W. entrances of: Inverness Drive, Shadow Creek Circle, Shadow Creek Drive, and Hazeltime Drive with Masonry by Fernando, Inc. for an amount not to exceed \$20,600.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Masonry by Fernando, Inc. for said work in an amount not to exceed \$20,600.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2017-116.




