ORDINANCE NO. 2017-117

AN ORDINANCE WAIVING THE COMPETITIVE BIDDING PROCESS AND AUTHORIZING THE VILLAGE TO EXECUTE A CONTRACT WITH BRIGGS PAVING (A DIVISION OF CONSTRUCTION MANAGEMENT CORP. OF AMERICA) TO REMOVE AND REPLACE THE EXISTING ASPHALT WALKING PATH AT THE ARBORTHEATRE FOR AN AMOUNT NOT TO EXCEED \$32,117.52

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village has budgeted funds within the 2017-18 Fiscal Year budget under account (0209081-550030) for path replacement at the Arbortheatre; and

WHEREAS, said path is original to the Arbortheatre site and is in need of replacement to ensure continued safety and use by pedestrians; and

WHEREAS, Brigg's Paving (A Division of Construction Management Corporation of America) has provided the Village with a proposal to remove and replace approximately 5,620 sq. feet of walking path at the Arbortheatre for an amount of \$32,117.52; and

WHEREAS, Brigg's Paving has performed similar work at the Arbortheatre for the Village in the past, and staff knows that they can complete the scope of work successfully; and

WHEREAS, expenditures over \$20,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents for the removal and replacement of approximately 5,620 sq. feet of walking path at the Arbortheatre with Brigg's Paving (A Division of Construction Management Corporation of America) for an amount not to exceed \$32,117.52.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Briggs Paving (A Division of Construction Management Corporation of America) in an amount not to exceed \$32,117.52.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2017-117.




