

**ORDINANCE 2017-132**

**AN ORDINANCE DECLARING CERTAIN VILLAGE PROPERTY TO BE SURPLUS AND PROVIDING FOR THE SALE BY PUBLIC OR INTERNET AUCTION**

**WHEREAS**, it has been determined according to the state statutes and Village ordinances by the corporate authorities of the Village of Vernon Hills that there exist certain surplus property; and

**WHEREAS**, the corporate authorities desire to sell the surplus property by public or internet auction.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:**

**SECTION I.** The following Village property is found and declared to be surplus:

1. 2003 Ford Taurus Sedan VIN: 1FAFP53283G241788
2. 2008 Ford Expedition VIN: 1FMFU16528LA64831
3. 2012 Chevrolet Tahoe VIN: 1GNLC2E00CR237524

**SECTION II.** The surplus property is to be sold through a public or internet auction.

**SECTION III.** The surplus property shall individually be withdrawn from the sale at the public or internet auction unless the following minimum sum shall be bid for the property:

1. 2003 Ford Taurus Sedan VIN: 1FAFP53283G41788 described in Section I (1) above, the minimum acceptable sum shall be \$200.
2. 2008 Ford Expedition VIN: 1FMFU16528LA64831 described in Section I (2) above, the minimum acceptable sum shall be \$2,000.
3. 2012 Chevrolet Tahoe VIN: 1GNLC2E00CR237524 described in Section I (3) above, the minimum acceptable sum shall be \$2000.

**SECTION IV. SEVERABILITY.** In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications that are severable, the valid applications shall remain in effect.

**SECTION V. REPEAL AND SAVINGS CLAUSE.** All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

**SECTION VI. EFFECTIVE DATE.** This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

**SECTION VII. PUBLICATION.** This ordinance shall be published in pamphlet form in the manner provided by law.

**SECTION VIII. ORDINANCE NUMBER.** This ordinance shall be known as Ordinance Number 2017-132.


