



**AN ORDINANCE AWARDING THE 2018 ROAD REHABILITATION PROJECT TO PETER  
BAKER & SON FOR AN AMOUNT NOT TO EXCEED \$166,671.10**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the President and Board of Trustees approved a budget of \$500,000 within budget account (0309109-550050) to cover costs associated with the 2018 Road Rehabilitation Project; and

**WHEREAS**, the road resurfacing work will be performed within the Deerpath Subdivision on Lindon and Midway Lanes; and

**WHEREAS**, the 2018 Road Rehabilitation Program plans were publicly bid and opened on February 27, 2018 with Peter Baker & Son of Lake Bluff, Illinois, submitting the lowest qualifying bid of \$166,671.10; and

**WHEREAS**, an ordinance is required for the award of bids and/or contracts.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute all required documents to award the contract to Peter Baker & Son for the 2018 Road Rehabilitation Project.

**SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make payments to Peter Baker & Son for an amount not to exceed \$166,671.10 within the 2018-19 Fiscal Year for the 2018 Road Rehabilitation Project.

**SECTION 3: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2018-036.




