AN ORDINANCE AUTHORIZING EXPENDITURES OVER \$20,000 TO LAFORCE, INC. TO PURCHASE REPLACEMENT FIBERGLASS DOORS AND FRAMES FOR THE PUBLIC WORKS BUILDING IN AN AMOUNT NOT TO EXCEED \$28,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois ("the Village") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the condition of the existing exterior, steel-framed doors at the Public Works building are in poor condition and have deteriorated and rusted from exposure to road salt and moisture; and

WHEREAS, the Village budgeted \$30,000 within FY2017-18 budget account (0209046-550040) to replace six (6) double doors, one (1) paired door, and one (1) single door with rust-resistant fiberglass doors; and

WHEREAS, LaForce, Inc. is considered an accessible, and reputable source for purchasing special fiberglass doors; and

WHEREAS, the Village received a quote from LaForce, Inc. to purchase all eight doors for an amount of \$27,766; and

WHEREAS, Public Works staff will perform the removal and installation of all eight doors inhouse; and

WHEREAS, consolidated purchases throughout the budget year of over \$20,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents with LaForce, Inc. for the purchase of eight (8) replacement fiberglass doors and frames per Quote #352404QU dated 4/5/2018.

<u>SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT:</u> The Finance Director is hereby authorized to make payment to LaForce, Inc. for the purchase of said doors and frames in an amount not to exceed \$28,000.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2018-068.
