ORDINANCE NO. 2018-114**

**AN ORDINANCE AUTHORIZING PAYMENT TO WINDY CITY AMUSEMENTS, INC.  
FOR THE PROVISION OF THE FISCAL YEAR 2018 – 2019  
SUMMER CELEBRATION CARNIVAL FOR AN AMOUNT NOT TO EXCEED \$100,000**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, Resolution 2013-182 authorized a five-year contract between the Village of Vernon Hills (*“Village”*) and Windy City Amusements, Inc. (*“Windy City”*) for the provision of the Summer Celebration Carnival; and

**WHEREAS**, the Village would like to continue its contract with Windy City for the provision of the Summer Celebration Carnival; and

**WHEREAS**, it is projected that the FY 2018-19 required payment to Windy City will be between \$75,000 and \$100,000 for the provision of the annual Summer Celebration Carnival; and

**WHEREAS**, all expenditures in excess of \$25,000 require Village Board approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:** The Village Manager and Assistant to the Finance Director are authorized to make a payment to Windy City Amusements, Inc. for an amount not to exceed \$100,000 upon receipt of documentation of the amount due and payable for the Summer Celebration Carnival and release the payment prior to the payment appearing on the Invoice Approval Report.

**SECTION 2: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2018-114.




