

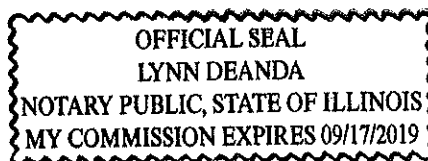

ORDINANCE 2018-131

AN ORDINANCE AUTHORIZING EXPENDITURES OVER \$25,000 TO MORTON SALT INC. FOR THE PURCHASE OF 1,200 TONS OF BULK ROAD SALT IN AN AMOUNT NOT TO EXCEED \$77,000 FOR THE 2018/2019 WINTER SEASON

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Public Works Department has budgeted funds for the purchase of bulk road salt in the FY2018-19 Street Maintenance Supplies account (0102053-530090); and

WHEREAS, the Village has participated in the Lake County Joint Purchasing Bid for the purchase of bulk road salt with Morton Salt Inc. being the winning bidder and providing salt at a rate of \$64.14 per ton; and

WHEREAS, staff's recommended quantity of salt for the Village to commit to for the 2018-19 season is 1,200 tons with an existing reserve of 300 tons; and

WHEREAS, the Village of Vernon Hills will be under contractual obligation to purchase 80% (960 tons) of the committed purchase amount, and the salt provider is required to supply up to 100% of the committed purchase amount; and

WHEREAS, all purchases over \$25,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents for the purchase of 1,200 tons of bulk road salt through Morton Salt Inc. at a price of \$64.14 per ton within the 2018-19 Fiscal Year.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Morton Salt Inc. in an amount not to exceed \$77,000 within the 2018-19 Fiscal Year.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2018-131.


