ORDINANCE 2019-090

AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO CALL ONE FOR THE PURCHASE OF TELEPHONE SERVICES FOR FISCAL YEAR 2019-2020 IN AN AMOUNT NOT TO EXCEED \$52,940

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois ("*the Village*") is a duly organized and existing municipality and unit of government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village must maintain telephone services for Village buildings; and

WHEREAS, Call One is considered a source determined by the Village to be beneficial to the Village as a supplier of telephone services for the Village of Vernon Hills; and

WHEREAS, the Village Board approved the 2019-2020 budget which includes \$52,940 for various phone services; and

WHEREAS, all expenditures and purchases over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents to purchase telephone services from Call One at a price not to exceed \$52,940.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Call One during Fiscal Year 2019-2020 in an amount not to exceed \$52,940.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2019-090.
