AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO ADVANCED BUSINESS GROUP LLC FOR THE PURCHASE OF INTERNET ACCESS AND PROTECTION FOR FISCAL YEAR 2019-2020 IN AN AMOUNT NOT TO EXCEED \$36,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (“*the Village*”) is a duly organized and existing municipality and unit of government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Advanced Business Group LLC, which is affiliated with Advanced Business Networks, is a reseller of fiber internet connections; and

WHEREAS, the Village requires internet connectivity and network monitoring; and

WHEREAS, Advanced Business Group LLC provides internet access including managed security, redundancy and network monitoring; and

WHEREAS, the Village has determined that Advanced Business Group LLC is a cost effective sole source provider of internet access and monitoring; and

WHEREAS, all expenditures and purchases over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Advanced Business Group LLC in an amount not to exceed \$36,000 for Fiscal Year 2019-2020 internet connectivity and network monitoring.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2019-091.




