ORDINANCE 2019-055

AN ORDINANCE INCREASING THE RATE AT WHICH GROUPS AND ORGANIZATIONS ARE TO REIMBURSE THE VILLAGE FOR SPECIAL POLICE SERVICES EFFECTIVE JUNE 1, 2019

WHEREAS, Resolution 2003-98 established that the police department will bill for special police services i.e.; traffic direction, special protections, etc; and

WHEREAS, the current billing rate is \$62.50 per hour; and

WHEREAS, the current billing rate has been in effect since 2012; and

WHEREAS, the Union and Village have agreed to raise the current billing rate to \$65.00 per hour; and

WHEREAS, the new billing rate will be effective from June 1, 2019 until April 30, 2022;

NOW THEREFORE BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

SECTION 1: DETAIL RATE TO CHARGE GROUPS AND ORGANIZATIONS:

The Village Board has determined the provision of special police services will be billed at \$65.00 an hour, and at \$130.00 an hour on holidays beginning June 1, 2019.

SECTION 2: EFFECTIVE DATE; This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2019-055.




