AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES OVER \$25,000 TO THE HOME DEPOT FOR THE PURCHASE OF GENERAL PURPOSE TOOLS AND MISC. BUILDING, ELECTRICAL, PLUMBING, GROUNDS SUPPLIES THROUGHOUT THE FY2020 BUDGET YEAR NOT TO EXCEED \$33,000

WHEREAS, The Home Depot is a local source proven to be beneficial to the Village as a supplier of general purpose tools, materials, and supplies purchased for general maintenance and repairs; and

WHEREAS, the Village Board approved the FY2020 budget which delineates funds for the purchase of tools, materials, and supplies required to maintain each of the Village's many properties; and

WHEREAS, consolidated purchases throughout the budget year of over \$25,000 require Board of Trustee approval.

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: THAT, the Finance Director is authorized to execute payments to The Home Depot for the purchase of general purpose tools and miscellaneous building, electrical, and plumbing supplies throughout the FY2020 budget year in an amount not to exceed \$33,000.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effective from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2019-065.


