ORDINANCE 2019-070

AN ORDINANCE AUTHORIZING APPROVAL TO WAIVE THE COMPETITIVE BIDDING PROCESS AND AUTHORIZE AN EXTENSION OF THE AGREEMENT WITH CLARKE MOSQUITO MANAGEMENT, INC. TO PERFORM MOSQUITO ABATEMENT SERVICES FROM 2019-2021; AND TO AUTHORIZE EXPENDITURES WITHIN FY19-20 TO NOT EXCEED \$75,650

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village of Vernon Hills entered into an agreement in 2013 with Clarke Mosquito Management, Inc. for the Village of Vernon Hills Environmental Mosquito Management Program effective from 2013-2015; and extended from 2016-2018; and

WHEREAS, Clarke Mosquito Management, Inc. has proven to be a beneficial and reliable source; therefore, the Village has continued its relationship with Clarke Mosquito Management, Inc. to provide mosquito abatement services; and

WHEREAS, the Village has received a proposal from Clarke Mosquito Management, Inc. to extend said agreement three (3) additional years from 2019 through the 2021 season; and

WHEREAS, the said three (3) year contract allows for Clarke Mosquito Management to increase the cost for services for FY20-21 and FY21-22 by a percentage which shall not exceed the lesser of the percentage increase of the consumer price index (CPI) or a maximum of 5% (Price Increase Percentage); and

WHEREAS, the Village Board has approved the FY19-20 budget that delineates funds for insect control services under account (0102040-520610); and

WHEREAS, the base cost for the 2019 Environmental Mosquito Management Program is \$57,030; and

WHEREAS, Surveillance and Monitoring; including one New Jersey light trap and one oviposition or gravid trap is included in the cost; and

WHEREAS, larval control includes three inspections of 130 sites, six targeted inspections of 64 sites, and three Culex targeted inspections of 40 sites, and four treatments of 2500 catch basins; and

WHEREAS, the cost for 2019 Ultra Low Volume (ULV) Treatments using Mosquitomist, four (4) community wide, July 4th, and the Summer Celebration is included in the above cost; and

WHEREAS, the cost for an additional community wide ULV Treatment will be billed at \$4,935; and

WHEREAS, the ULV treatment cost for Arbortheatre events and other special events is estimated at \$200 per special event; and

WHEREAS, additional funds will be found within the Public Works FY19-20 budget via a budget transfer with anticipation that two additional community-wide ULV treatments and a few additional special event sprays may be necessary dependant upon unanticipated climate and mosquito populations; and

WHEREAS, consolidated purchases throughout the budget year of over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents for contractual mosquito abatement services with Clarke Mosquito Management Services for three years from 2019-2021 at a price not to exceed \$75,650 within the 2019-2020 Fiscal Year.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is authorized to execute payments to Clarke Mosquito Management, Inc. for Environmental Mosquito Management services throughout the FY19-20 budget year in an amount not to exceed \$75,650.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2019-070



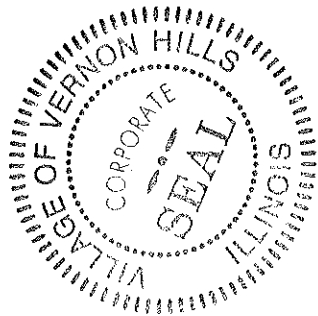


