ORDINANCE 2019-082

AN ORDINANCE AUTHORIZING APPROVAL OF PAYMENT TO ADVANCED BUSINESS NETWORKS INC. FOR ADDITIONAL INFORMATION TECHNOLOGY SUPPORT NEEDED DUE TO GIS COORDINATOR DEPARTURE FOR FISCAL YEAR 2019-2020 IN AN AMOUNT NOT TO EXCEED \$83,200

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (“*the Village*”) is a duly organized and existing municipality and unit of government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village uses Advanced Business Networks Inc. for its information technology support; and

WHEREAS, Advanced Business Networks Inc. will provide additional information technology support due to the departure of the GIS Coordinator, and provide on-site access from IT technical staff ; and

WHEREAS, Advanced Business Networks Inc. offers a block of over one hundred days of contractual Information Technology support at a discount; and

WHEREAS, the Village’s FY2019-20 budget anticipated a cost for a GIS Coordinator; and

WHEREAS, all expenditures and purchases over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Advanced Business Networks Inc. in an amount not to exceed \$83,200 for Fiscal Year 2019-2020 immediately upon approval, for information technology support.

SECTION 2: AUTHORIZATION TO TRANSFER OF FUNDS: The Finance Director is authorized to increase the budget account 0101005-520220 (information technology service) by \$83,200 and decrease the budget account 0106008-50010 (full time salaries) via a budget transfer.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2019-082.


