ORDINANCE 2019-083

AN ORDINANCE AUTHORIZING APPROVAL OF PAYMENT FOR GIS SERVICES TO WILL ROCKWELL FOR FISCAL YEAR 2019-2020 IN AN AMOUNT NOT TO EXCEED \$65,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (“*the Village*”) is a duly organized and existing municipality and unit of government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village elected to not fill the vacancy of the GIS Coordinator position; and

WHEREAS, the Village researched other options to provide GIS services; and

WHEREAS, the other GIS services options could not be implemented during the time period services were needed, and the completed product could not be delivered for current and pending Village projects; and

WHEREAS, Will Rockwell has the capabilities to provide GIS services remotely and efficiently; and

WHEREAS, the Village’s FY2019-20 budget anticipated a cost for a GIS Coordinator; and

WHEREAS, all expenditures and purchases over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to process a purchase order and make payment to Will Rockwell in an amount not to exceed \$65,000 for Fiscal Year 2019-2020 for GIS support.

SECTION 2: AUTHORIZATION TO TRANSFER OF FUNDS: The Finance Director is authorized to increase the budget account 0106008-520990 (contractual service) by \$65,000 and decrease the budget account 0106008-50010 (full time salaries), 0106008 (various employee benefit accounts) no longer needed via a budget transfer.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2019-083.






