**ORDINANCE 2019-092**

**AN ORDINANCE AUTHORIZING A PAYMENT TO NORTHEASTERN ILLINOIS REGIONAL CRIME LAB FOR ANNUAL MEMBERSHIP IN AN AMOUNT NOT TO EXCEED \$37,154**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois ("*the Village*") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, Police Department has identified that continued membership in the Northeastern Illinois Crime Lab is essential to the performance of providing police service to the Village of Vernon Hills. Over the years the Northeastern Illinois Crime Lab has provided the police department with professional, accredited laboratory and crime scene processing, training and assistance. The Village of Vernon Hills has been a member in good standing for several years and each year the quality of service provided continues to improve; and

**WHEREAS**, The Northeastern Illinois Regional Crime Lab has been identified as a sole source provider of services that are necessary for successful police operations; and

**WHEREAS**, all purchases over \$25,000 require Board of Trustees approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS**, as follows:

**SECTION 1: EXECUTION OF PAYMENT.** The Finance Director is hereby authorized to issue payment to Northeastern Illinois Regional Crime Lab for annual membership in an amount not to exceed \$37,154.

**SECTION 2: EFFECTIVE DATE.** This Ordinance shall be in full force and effect upon its passage and approval by a majority of the members of the Village Board.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2019-092.


