

RESOLUTION 2019-038

A RESOLUTION AUTHORIZING THE VILLAGE PRESIDENT TO EXECUTE A TRAFFIC AND PARKING REGULATION AGREEMENT WITH SCHOOL DISTRICT 128 REGARDING TRAFFIC AND PARKING ENFORCEMENT ON THE VERNON HILLS HIGH SCHOOL CAMPUS

WHEREAS, the VILLAGE OF VERNON HILLS, Lake County, Illinois (the "Village") is a home rule municipality, pursuant to Article 7, Section 6 of the Illinois Constitution of 1970; and

WHEREAS on September 19, 2000, School District 128 entered into an agreement with the Village of Vernon Hills extending the Village the right to enforce traffic and parking regulations on the Vernon Hills High School Campus ("VHHS Campus"); and

WHEREAS, the existing agreement expires on September 18, 2020 and School District 128 is desirous of extending the existing agreement to provide for the regulation of traffic and parking on the Vernon Hills High School District Campus ("VHHS Campus"); and

WHEREAS, the President and Board of Trustees deem it to be in the best interests of the Village to enter into such a new agreement with School District 128 to provide for the Village's enforcement of traffic and parking regulations on the VHHS Campus; and

WHEREAS, the Village is empowered to enter into such an agreement under its home rule powers and pursuant to Section 11-209 of the Illinois Vehicle Code, 625 ILCS 5/11-209 and Section 1-1-7 of the Illinois Municipal Code 65 ILCS 5/1-1-7; and

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

1. That the Traffic and Parking Regulation Agreement between the Village of Vernon Hills and School District 128 is approved and that the President and Village Clerk be and hereby are authorized and directed to execute the agreement attached hereto as Exhibit A.
2. The Traffic and Parking Regulation Agreement shall be recorded in the Office of the Recorder of Deeds of Lake County.

EXHIBIT A

**TRAFFIC AND PARKING REGULATION AGREEMENT WITH SCHOOL DISTRICT 128
REGARDING TRAFFIC AND PARKING ENFORCEMENT ON THE VERNON HILLS HIGH
SCHOOL CAMPUS**

Compiled Statutes.

B. The District shall bear the cost of the installation of such additional signs, signals and markings as determined to be required pursuant to the terms hereof and/or the ordinances of the Village. Provided, however, the District shall be consulted prior to the installation of such signs on the VHHS campus and no sign shall be installed if the District reasonably objects to such installation.

C. The authorizations contained under the terms of this agreement shall be in addition to any other authority of the Village existing by reason of any other Statute of the State of Illinois and/or ordinances of the Village of Vernon Hills and such additional authorizations shall not be construed to be in lieu of such other Statute or law.

D. That the term of this agreement shall be for five (5) years from the date hereof and be automatically renewable to three (3) additional five-year terms unless cancelled by either party at any time upon at least sixty (60) days' prior written notice to the other party.

E. This agreement supersedes in their entirety, any prior agreements of the same nature pertaining to the regulation of traffic on the VHHS campus.

F. That this agreement shall be recorded in the office of the Recorder of Deeds of Lake County, Illinois.




